CSR Policy

1.0 Background

4.0 Validity of CSR Policy

The Board shall review the CSR policy from time to time and may amend as may be required.

5.0 CSR Program Areas & Objectives

- 4) Promoting education including special education and employment enhancing vocation skills especially among children, women, elderly, and the differently abled and livelihood enhancement.


6.0 CSR Budget

- 2. The Company may collaborate or pool resources with other organizations or companies to undertake CSR activities.
- 3. The surplus arising out of the CSR projects or programs or activities will be included in the CSR Corpus and shall not form part of the business profit of the company.

7.0 Implementation process

- CSR program will be undertaken by the Company within the defined ambit of CSR policy.
- ❖ The time period/duration over which a particular program will be spread, will depend on its nature, extent of coverage and the intended impact of the program.
- ❖ The Company will enter into partnerships with the government, business partners and communities to create multiplier effect of its social projects.
- ❖ The mode of implementation of CSR programs will include a combination of direct implementation and implementation through partners such as NGOs, business partners, registered trusts and societies etc. The Company will select its partners after appropriate due diligence.
- The Company may use services of expert agencies, consultancy firms etc. wherever required for carrying out surveys, guidance on project designand implementation, impact assessment surveys etc.

- ensuring that it specifies thereasons inits report for not spending the earmarked amount in case the Company fails to spend such amount.

- Kaka-Ba Hospital, established in 1985 at Hansot, Dist. Bharuch, Gujarat is run by Kaka Ba and Kala Budh Public Charitable Trust and is the hub of CSR activities run by Cadila Pharmaceuticals Limited.
